Understanding CBAM:

What it means for your business.

CBAM is designed to prevent carbon leakage by imposing carbon costs on certain imported goods, aligning them with EU emissions standards.

Affected commodities include:

- Iron & steel
- Aluminium
- Cement
- Electricity
- Fertilisers
- Hydrogen

Companies importing these goods into the EU must report embedded carbon emissions and pay associated tariffs. Compliance will be phased in, requiring businesses to adapt quickly to new regulatory expectations.

Affected groups include:

- EU importers Report emissions and purchase certificates
- Non-EU producers Monitor and disclose emissions data
- EU consumers Request emissions data from suppliers







Implementation timeline & key deadlines.

- 2023-2025 Transitional phase: Importers must report emissions without financial adjustments.
- 2026 onwards Full implementation: Importers must pay for embedded emissions.











Why act now?

- Strict deadlines apply Late or inaccurate reporting could lead to enforcement actions.
- Prepare early Collecting and verifying emissions data takes time.
- Non-compliance is not an option Stay ahead of regulations to avoid substantial fines and disruptions.
- Plan for modifications Submission errors can be corrected, but only within the set timeframe.


