Understanding packaging EPR fees

Under the new Packaging Waste Regulations, producers now fund the collection, sorting, and recycling of packaging waste.

From 2026 onwards, fees will be calculated using modulated rates, meaning the harder your packaging is to recycle, the higher your costs. The 2025 fees are not modulated, but understanding future cost drivers now will help businesses prepare and avoid higher fees in later years.

Key cost drivers include:

- Material recyclability and complexity
- Volume of packaging placed on the UK market
- Accuracy of data submissions
- Product design and component mix
